#### Time Zone Used – Central Daylight Time (CDT) Local

**Task Organization:** Participating personnel and equipment are under the operational control of the ALWG CC's designated authority or designated Incident Commander (OPCON)

#### I. SITUATION.

- A. CAP-USAF. In accordance with the requirements established by the cooperative agreement between the Civil Air Patrol (CAP) and the United States Air Force, CAP and CAP-USAF will conduct a joint FY23 Ops Eval of CAP operations to evaluate each region's and wing's ability to conduct assignable missions in a safe and effective manner. The intent of the Ops Eval is to assess normal operations during execution of routine missions.
- B. Evaluated sorties will focus on historical AFAM missions.
- C. ALWG has been identified as a select wing for the purposes of the FY24 Ops Eval.
- **II. MISSION.** As directed by the ALWG CC, select ALWG members will participate in the FY 24 CAP and CAP-USAF joint Ops Eval intended to evaluate the wing's ability to conduct the spectrum of potential USAF assignable missions. Evaluation activities will take place throughout the fiscal year and from multiple operational locations. In addition. Select members may be requested to assist in the evaluation of other wings within Southeast Region.

#### **III. EXECUTION.**

- A. Commander's Intent. ALWG's designation as an "emphasis wing" provides us the opportunity to display the professionalism of our volunteer membership to staff representing CAP-USAF, CAP NHQ, SER, and adjacent wings. As we conduct evaluated sorties, we want to remain cognizant that everything from precise airmanship in execution of flight profiles to how individuals proudly and correctly wear our uniform will add to the perception our visitors will depart with. As always, safety and cadet protection in all we do remains paramount.
- B. Concept of Operations.
  - 1. In coordination amongst the ALWG DO, CAP-USAF, NHQ Ops Eval team, and Southeast Region mission events will be identified to evaluate. Evaluation staff will be designated, evaluations conducted, and evaluation dat compiled and forward to CAP-USAF.
  - 2. Any AFAM mission is available to be evaluated. Though evaluators will focus on evaluating sorties as noted in Annex A, opportunities to evaluate additional sorties are permitted. ALWG can expect evaluators to try to view last minute events including search and rescue and disaster relief missions. Evaluators will coordinate as far ahead as practical with a goal of 7-day notice for routine and planned events.
- C. Orders to Subordinate Elements.
  - 1. ALWG DO/POC will:

- a. Maintain close coordination with the SER CAP-USAF LR, SER Ops Eval, POC, as well as the NHQ Ops Eval team to identify and nominate candidate sorties for evaluation, schedule sorties, assist evaluators, and provide documentation needed to complete the Ops Eval.
- b. Monitor the 24 Ops Eval dashboard regularly to assure accomplishment of 100% of evaluation requirements.
- c. Provide a weekly verbal status to the ALWG CC on competition of sorties evaluations.
- d. Provide a status briefing on sortie evaluation completion at the monthly assembly of the command and staff.
- e. Request assistance from SER in scenario development for the scheduled Wing Led Exercise (WLE A5 mission) to include drafting exercise injects and RED TEAM participants.
- f. Host a monthly Initial Program Review (IPR) w/key stakeholders (ALWG CC, CV, DO, Standards, Safety, and Maintenance) to update and coordinate OPS EVAL requirements.
- 2. ALWG Aircraft Maintenance Officer. Will coordinate with group CCs and provide staff assistance for the completion of an inspection of individual Aircrew Information Folders for all assigned aircraft for compliance with CAPS 72-4 and CAPF 70-8.
- 3. ALWG Standardization/Evaluation Officer. Will assist the DO in nominating sorties and aircrew for evaluation during the course of the FY 24 Ops Eval.
- 4. Groups.
  - NLT 1 November 2023, Groups will inspect individual Aircrew Information Folders for assigned aircraft for compliance with CAPS 72-4 and CAPF 70-8. Corrective actions for identified shortfalls will be completed NLT 15 November 2023.
  - b. Will nominate to the DO sorties and aircrew for evaluation during the course of the FY 24 Ops Eval.
- 2. Participating Members. Upon notification that an operational activity is scheduled for evaluation, the individual or aircrew members will:
  - a. Review evaluation criteria Annex B and provide a backbrief of their review to the Group CC's designated representative.

- b. Inspect aircraft, vehicles, and other equipment to be utilized during the evaluation.
- D. Coordinating Instructions.
  - 1. CAP and CAP-USAF Region Commanders must approve pilots and other crew members being evaluated on multiple sorties. Commanders may need to allow the same pilot or crew to be evaluated multiple times if they are the only pilot or crew available and qualified to meet mission needs.
  - 2. Evaluation Criteria:
    - a. Annex A (ALABAMA WING OPERATIONAL EVALUATION SORTIE REQUIREMENTS)
    - b. Annex B (KEY PERFORMANCE QUESTIONS AND KEY PERFORMANCE INDICATORS)
    - c. Special Interest Items (SII) for FY24:
      - SII 1: Completion of all pre- and post-mission paperwork (CAPFs 104) including specific mission accomplishments.
      - SII 2: Coordination of after-action reports with the customer.
      - SII 3: IC completion of a daily/weekly SITREP and coordination with the appropriate LR.
      - SII 4: Following guidance as outlined in approved regulations and operation plans.
      - SII 5: Using the Wing training plan to drive sortie training requirements.
      - SII 6: Up to date Aircrew Information Folder (AIF) IAW CAPS 72-4 and CAPF 70-8.
      - SII 7: Completion of CAPF 73 when a vehicle is used (corporate or POV) for official CAP duties.
    - d. Other Evaluation Areas: Incident Command Post (ICP) and other critical functions remain centrally important to CAP. NHQ will specifically strive to send evaluators to operations during a WLE (Wing Lead Exercise) A5 mission. ALWG has scheduled and informed evaluation staffs that the wing will conduct a WLE from 16-18 August 2024 at Bessemer Airport, Bessemer, Alabama.
    - e. Sortie Failures: An individual evaluation is a failure if it generates five or more negative responses. Evaluators will inform both the Region and the Liaison Region (LR) Commanders. In the event of an individual failure, a new evaluator from either the CAP-USAF/LR or CAP, and CAP-USAF HQ will be assigned to conduct the repeat evaluation. In the event of a

second failure in the same mission set, the CAP/DO or CAP-USAF/DO or their designee will conduct the repeat evaluation. A sortie will receive an automatic failure for a safety of flight or cadet protections issue.

#### **IV. SERVICE SUPPORT:**

- A. Administration and Personnel:
  - 1. All participants will be active CAP members with valid ID card in their possession. All members must have completed General Emergency Services and Basic ORM training and have those qualifications reflected in eServices.
  - 2. Wear of duty appropriate uniforms IAW CAPR 39-1 is required of all mission participants. CAP identification card and CAPF 101, CAP Specialty Qualification Card, will be carried on person.
  - 3. Use of WMIRS for mission record keeping is mandatory.
- B. Logistics.
  - 1. Funding. No additional funding other than found in the ALWG FY 24 operational budget is allocated for the conduct of evaluated sorties. A specific mission number and funding will be forthcoming to support inter-wing travel for select evaluators.
  - 2. Petroleum, Oil, and Lubricants (POL).
    - a. Corporate aircraft will obtain POL products through Fixed Base Operators; payment will be made using the National Credit Card
    - b. The ALWG Form 173-RA, Alabama Wing Fuel/Oil Receipt Checklist and Addendum, and associated receipts will be uploaded to the WMIRS sortie within 24 hours of purchase. The upload will be a one-page PDF document with the fuel form and receipts side by side.
  - 3. Maintenance. Participating elements will coordinate with the ALWG Maintenance Officer for unscheduled maintenance requirements.
  - 4. Information Management. ALWG Public Information Officer (PIO) will provide initial guidance for participating member interactions with the media and public. Air crews will refer all media inquiries to the IC.

#### A0/A24 – 1

- **A0** Onboarding training for cadet (not in Wings Program) and senior member pilots holding at least a Private Pilot Certificate conducted in accordance with the appropriate CAPS 71-series Onboarding syllabus. Onboarding Form can be funded on the Wing A7/B7 mission.
- A24 Return to Flight training for pilots who, due to no fault of their own, have experienced an interruption in their flying activity that resulted in expiration of their qualifications. Must be conducted in accordance with the appropriate CAPS 71- series Return to Flight syllabus. Return to Flight Form 5s can be funded on the Wing A7/B7 mission.

A5 AF training and evaluation missions.

#### A6/8/15/19 - 2

- A6 Air Force Reserve Officer Training Corps (AFROTC) orientation flights, including flights to and from the orientation site and tow sorties in support of Orides in gliders.
- **A8** Air Force Junior Reserve Officer Training Corps (AFJROTC) orientation flights including flights to and from the orientation site and tow sorties in support of Orides AFAM in gliders.

A-18 Air Defense intercept and Target of Interest missions.

#### A23 – 1

A23 Air Force approved Technically Advanced Aircraft (TAA) Training sorties and sorties supporting aircraft upgrades.

- A27 Flight training for CAP cadets not holding at least aPrivate Pilot Certificate and leading to an additional airman rating, certificate, rating, or endorsement. (Must be flown AFAM on a CAP approved syllabus.)
- A28 Individualized flight training for cadets not holdinga Private Pilot Certificate and leading to an initial FAA certificate, rating, or endorsement, (Must be flown AFAM on a CAP approved syllabus.)
